Evaluation Report Title: Evaluation of the South Asia Water Initiative Phase II

Response to Evaluation Report (overarching narrative)

The Department for International Development (DFID) commissioned Oxford Policy Management (OPM) to conduct the evaluation of the South Asia Water Initiative Phase II (SAWI II) multi donor trust fund (MDTF \$31m)).

SAWI aims to increase regional cooperation in the management of the major Himala-yan river systems in South Asia to deliver sustainable, fair, and inclusive development and climate resilience. It operates across seven countries: Afghanistan, Bangladesh, Bhutan, China, India, Nepal, and Pakistan. Phase II (2013–December 2018) is funded by the DFID (56%), Australia (36%), and Norway (8%). The evaluation was conducted from October 2017 to April 2018.

The objective of this evaluation was to understand the extent to which the SAWI-II MDTF is delivering on its overall aim to increase regional cooperation in the management of the major Himalayan river systems in South Asia to deliver sustainable, fair, and inclusive development, and climate resilience. It also provided learning for future programming on trans-boundary management of international rivers.

The Evaluation found that the SAWI II strategy was underpinned by context, detail and rationale for planned activities. Implemented activities were broadly perceived as appropriate. As the implementing agency, the World Bank effectively mobilised world class expertise in water related sectors and its convening power was evident in its ability to involve key government ministries in SAWI II dialogues. Similarly, in country state and federal level actors could be convened by the Bank (both from government and the Civil Society Organisations (CSOs) for dialogue which open up the possibilities of a regional integration. The interventions (such as dialogues, trainings, knowledge products) under the programme have plugged key knowledge gaps on holistic river management and provided new opportunities for stakeholders to engage. Increased face to face engagements have led to trust building. The report concluded that SAWI-II has made important contributions towards building the capacity of technical experts within government and academia. SAWI II has helped to level the playing field on water resources management by strengthening the technical competence of stakeholders. There have been concrete examples of cooperation – A memorandum of understanding (MOU) has been signed for the Sundarbans, the Indus, and the Brahmaputra, for collaboration on technical issues.

SAWI-II helped to develop research networks and working relationships across borders and built momentum for future studies. The programme has helped put in place data-sharing platforms which will continue beyond the end of the programme. SAWI-II facilitated the formation of two government Integrated Water Resources Management (IWRM) units, which were created during the design of World Bank investment projects. SAWI-II's technical studies also informed the design of some programmes funded through national or other donor-funding.

The Evaluation has provided a set of recommendations to DFID for designing a future initiative on transboundary management of international rivers. Here, we present the recommendations for the remaining period of SAWI II initiative and our response with respect to the same:

Partially accepted	Needs assessment for capacity building activities is being conducted. For example, under the Brahmaputra focus area, a needs assessment is being conducted in order to identify capacity building activities related to disaster risk management. Whether or not a TOT model will be adopted will be decided on a case to case basis. It is being ensured that the capacity built is sustainable. A sustainability plan is also being drawn up.
4) Design additional capacity-building training for senior decision makers within the Government of Afghanistan.	Accepted	The Programme team is discussing training options with the Government of Afghanistan.
5) Conduct additional joint technical training sessions with stakeholders from India, Nepal, Bangladesh, and Bhutan on modelling tools and flood forecasting tools.	Accepted	A joint technical training session with stakeholders from India, Nepal, Bangladesh and Bhutan is being planned. The programme team expect to deliver this within a year. Joint technical training sessions on flood forecasting and modelling tools will be undertaken in the context of what has already been developed, by whom, and for which areas.
